- 2. The nomination papers shall be presented in person or sent by registered post as acknowledgement due, by the Candidate himself/herself or any other person authorized by him/her to the Returning Officer or the person authorized by the Returning Officer, CAMPCO Ltd., Varanashi Towers, Mangaluru so as to reach between 11.00 A M to 3.00 P M on any day other than the public holiday from 3<sup>rd</sup> November 2025 to 8<sup>th</sup> November 2025. The candidate or the proposer or the seconder may be present at the time of scrutiny.

- 3. Any candidate may withdraw his Candidature by Notice in writing signed by him, delivered in or by the person duly authorized by him at any time after the presentation of the nomination paper, but before date and time specified in the Election Programme for such withdrawal i.e. 11th November 2025 between 11.00 AM to 3.00 PM.
  - A notice of withdrawal of candidate once given shall be irrevocable.
- 4. As per Bye –Law No.28, a Member shall not be eligible for being elected, or continued as a Director of the Board of CAMPCO if the member incurs any of the disqualifications stipulated in section 43 of the Act and does not hold a minimum Share amount of Rs.10,000/- of the respective category having voting right at the time of contesting for election.
- 5. Those members who are contesting under SC/ST constituency they must compulsorily submit SC/ST certificate which shall be issued by the Competent Authority.

#### INSTRUCTION TO VOTER: -

In any election, identification of genuine voter is most essential for the success of election process. As per Rule 19 M (7) of the Multi State Cooperative Societies Rules 2002, every member who desires to exercise his vote, shall enter the polling station with an identity card given to him by the CAMPCO Ltd.
